1. Registration papers will be given to Buyer after receipt of payment in full. The Buyer agrees to register the pup/dog using the kennel name of HARLEY.
2. The Buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, and kept in optimum show condition. This includes, but not restricted to, coat kept in top condition, regular clipping of nails, proper weight control, bracing or taping of ears as necessary, and the maintenance of overall good health. This includes keeping this pup/dog parasite free and up to date with inoculations, proper nutrition, which consists of good quality professional feed, fresh water available at all times. Provide safe environment for the pup/dog. The pup/dog will be microchipped, have eye check and at least its first round of shots before leaving the Harley Collies.
3. Harley Collies guarantees this pup/dog to be of sound health and temperament at time of this sale. A health record of all shots and worming will be provided by Harley Collies. Buyer must have pup examined by their vet within 72 hours. If pup/dog is determined to be in ill health, the cause of which is clearly attributable to Harley Collies, the pup/dog may be returned for refund of the purchase price with signed written diagnosis from said veterinarian. Harley Collies will assume no responsibility if this pup/dog is given Ivermectin, Immodium or any of the collie-sensitive drugs and suffers an adverse reaction. No other guarantees are given.
4. If Buyer can no longer retain possession of this pup/dog, Harley Collies is to be notified and given first option of resuming full ownership of dog in order for Harley Collies to locate this pup/dog a new home. Pup/dog will be returned with all AKC papers and medical records. Harley Collies reserves the right to approve/prohibit any transfer of this pup/dog to a third party. Under no circumstances will this pup/dog be sold, leased, traded or given away to any pet shop, research laboratory, animal shelter or similar facility.
5. The Buyer agrees to contact Harley Collies immediately if any questions or concerns arise about the pup/dog, such as housing, diet, health or training. The Buyer agrees to keep the seller informed of any treatment as it occurs. This gives Harley Collies the opportunity to follow up on pup/dog and gives us feedback and information on the health.
6. The Buyer agrees that Harley Collies may examine and/or make inquiry about pup/dog and, if not satisfied with the conditions, may take possession of said pup/dog at any time.

The preceding paragraphs contain conditions established to ensure the well being of the dog, but also to uphold and maintain the reputation of quality that Harley Collies has established. The Buyer's agreements will continue for the dog's life and Harley Collies will have the right to enforce the agreements or agreement shall be declared null and void and Harley Collies has the right to repossess said pup/dog with no compensation to the Buyer.

- A. Outright sales
  - A1. Males  
Harley Collies reserves the option to use the dog(1) time for breeding with no stud fee being charged to bitches owned by Harley collies. Harley Collies hope that Buyer will turn away poor quality bitches.
  - A2. Females  
Harley Collies requests the opportunity to lease the bitch back for a full litter (at least two live pups) at a later date, and will pay the Buyer a leasing fee. The litter will be registered in the Harley name and the bitch will be returned to the Buyer as close to eight weeks after whelping as possible. Harley Collies will bear all shipping costs.
  - A3. Males/Females  
There are no provisions on this sale.
  - A4. Male/Female is sold on a co-ownership until agreement of terms has been satisfied.
